### **FULL EXCLUSIVE HIRE**

A venue hire fee is required to secure the date. No bookings will be confirmed until payment is made & we operate on a first come first served basis.

The fee includes a DJ should you require one, a skilled team to deliver any event & full exclusivity including set up time should you need.

The venue hire fee is non-refundable. If your booking is cancelled with more than 4 weeks' notice, the fee can be transferred to another date within a 6 month period from the original booking.

<u>Bookings cancelled with less than 4 weeks notice are non-refundable, and</u> will be forfeited in lieu of notice.

Guest numbers, food pre-orders & specific drink choices must be confirmed & paid for 14 days prior to event in addition to the hire fee.

Dietary requirements must also be confirmed 14 days prior to event. Please note that our kitchen is not 100% allergen free.

Should party numbers drop with less than 14 days notice, you will still be charged for the food pre-orders & specific drink choices based on number of guests confirmed & quoted with original booking.

Private hire is not confirmed until the agreed hire fee is paid & confirmation is sent by the blossom street SOCIAL manager. By submitting the hire fee you are agreeing to our terms & conditions, as laid out in this document.

In addition to the venue hire fee, a minimum spend must be met.

Should any organiser / company wish to pre-order & pay for food or drinks for their party the cost of this will be deducted from the minimum spend required. Should it be less than the required minimum spend card details will be held on our secure server until the event has finished. If the event has met minimum spend required based upon time/date/day no further monies will be taken.

If the final bill has fallen short the remainder will be charged to the card on file, the same day.

We add a discretionary service charge of 10% to all bills. We do not add 10% service to venue hire.

If you wish to change the time of your event at least 7 days' notice must be given & is subject to availability. blossom street SOCIAL cannot stay open later than our licensing agreement with Manchester City Council.

Any pre-ordered food will be served no later than 1 hour after event start time unless discussed & agreed otherwise.

Full venue hire allows decoration to be brought to the venue. However, nothing that can cause damage to our walls or furniture. Helium balloons cannot stay in the venue overnight & no table candles are permitted at the same time. We do permit Birthday cake candles.

Sorry to be a party pooper but we do not allow confetti or glitter as part of the venue decoration, as this can be incredibly difficult to clean.

In line with our licensing terms all guests must leave the venue quietly in respect to our neighbours.

In respect to smoking we have a covered area until 11pm. After that it is not covered regardless of the weather.

#### Costs for full venue hire are as follows -

Sunday – Wednesday £750.00 Thursday – Saturday £1000.00

### Minimum spend required in addition to venue hire fee are as follows -

Sunday – Wednesday £750.00 + 10% discretionary service charge Thursday - £1000.00 + 10% discretionary service charge Friday - £1500.00 + 10% discretionary service charge Saturday £2000.00 + 10% discretionary service charge

## **PARTIAL HIRE**

A minimum spend is required to be met. This varies based on the number of guests & when you require the space. The number of guests also determines what will be the best location for you in the venue. 50% of the minimum spend is required as a deposit for you to secure the booking.

A 10% service charge will be added to the minimum spend required.
